Sealed proposals will be received at the office of the Board of County Commissioners of Butler County, Ohio on the 6th Floor of the Butler County Government Services Center, 315 High Street, Hamilton, Ohio until 10:30 a.m. local time on Tuesday, September 15, 2009, and will be opened and read aloud at 10:45 a.m. or shortly thereafter in the Commissioners' Conference Room on the Sixth Floor in the Government Services Center, for the furnishing of all labor and materials required for the above DEMOLITION AND REMOVAL OF VARIOUS ABANDONED AND UNUSED STRUCTURES, PIPING AND EQUIPMENT AT THE LESOURDSVILLE WRF. Each proposal shall contain the full name and street address of the Bidder and every person or company interested in same. Each Bidder must submit evidence of its experience on projects of similar size and complexity. Each Bidder is required to complete the "Non Collusion Affidavit" and "Personal Property Tax Affidavit" and submit same with the proposal. Each proposal shall be accompanied by a Bid Guaranty in accordance with Section 153.54 of the Ohio Revised Code as a guarantee that if the bid is accepted, a contract will be entered into and performance properly secured by a contract bond in the amount of one hundred percent (100%) of the amount of the contract.

Bids shall be sealed and shall be clearly marked on the outside of the package "BIDS FOR LESOURDSVILLE WRF IMPROVEMENTS PHASE I – DEMOLITION AND REMOVAL CONTRACT." Failure to submit bid proposals in conformance with the Contract Documents will result in "rejection of the bid as non-responsive."

All contractors and subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services and labor in the implementation of their project. Additionally, contractor compliance with the Equal Employment Opportunity Requirements of the Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and the Governor's Executive Order 84-9 shall be required. Attention of Bidders is called to all requirements contained in the Contract Documents, particularly to the State of Ohio Equal Employment Opportunity Requirements and Bid Conditions of OPWC-Assisted Construction Projects. Bidders must comply with the prevailing wage rates on Public Improvements in Butler County, Ohio, as determined by the Ohio Bureau of Employment Services, Wage & Hour Division, (614) 644-2239.

DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.001 OF THE OHIO REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.001 OF THE REVISED CODE CAN BE OBTAINED FROM THE BUTLER COUNTY DEPARTMENT OF ENVIRONMENTAL SERVICES.
