**SANITARY SEWER REIMBURSEMENT AGREEMENT**

WHEREAS, the Board of County Commissioners of Butler County, Ohio did grant permission to \_\_\_\_\_, the developer of \_\_\_\_\_  
(Developer ) (Development)  
to extend the County's Public Sanitary Sewer System to and/or along said subdivision, and

WHEREAS, the County's policy on "Extension of Public Wastewater Collection Facilities", (Developer's Manual, BCWS 2009) provides for a partial reimbursement of expenses incurred by private developers through the extension of Public Sanitary Sewers that are outside of the development ("Off-Site Sanitary Sewers") and the extension of Public Sanitary Sewers along the development boundary across the frontage of adjacent non-participating properties, and

WHEREAS, the documented cost of the eligible sanitary sewer mains, as explained in said policy, was \$\_\_\_\_\_ of which \$\_\_\_\_\_ is considered eligible for reimbursement without interest, solely from future connection fees applied to all lots and parcels within the service area of the extended Sanitary Sewer Mains.

NOW THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Butler County, Ohio does hereby authorize reimbursement of Sewer Connection Fees applied against properties connecting directly to and/or tributary to the eligible sanitary sewer mains, as explained in said policy. Reimbursement shall be made from the following:

1. Local Sewer Connection Fee - up to \$ \_\_\_\_\_ per connection.
2. Trunk Sewer Capacity Fee - \$ \_\_\_\_\_ per connection (per Equivalent Residential Unit).

Reimbursement shall be made up to the established limits of reimbursable cost of \$\_\_\_\_\_, as full compensation for eligible sanitary sewer main costs, as explained in said policy. This reimbursement provision shall be valid for 10 years, as connection fees are collected, on a quarterly basis, beginning with the date of acceptance of the sanitary sewer main by the County. The right of the undersigned developer to receive reimbursement is not transferable without approval of the Board of County Commissioners, Butler County, Ohio.
